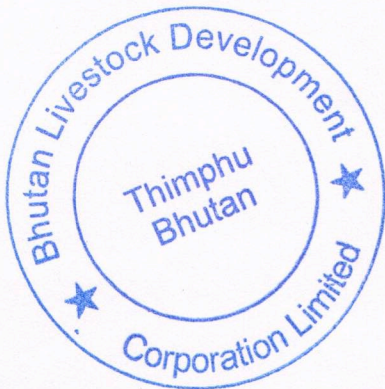

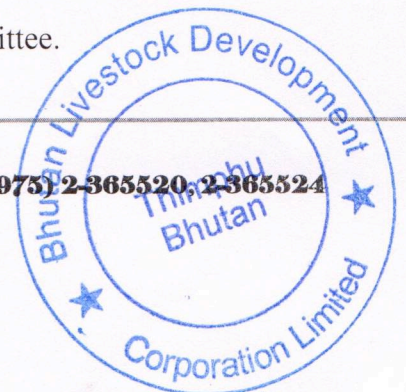
Terms and Condition

1. All the bidders shall pay Nu. 500.00 (Ngultrum Five Hundred) only, as an entrance fee, which shall not be non-refundable.
2. A person who attends the auction to bid on behalf of another person must produce a letter of authority that expressly authorizes him or her to bid on behalf of that person. When a person bidding on behalf of a company, the letter of authority must appear on the letterhead of the company.
3. Each bidder shall deposit the earnest money of Nu. 5,000.00 (Ngultrum Five Thousand) only in cash to the HR & Administration Services Division, BLDCL a week before the auction to qualify him/herself to bid for the auction. On receipt of the earnest money, a token is issued to identify the qualified bidder. A person without a token shall not be allowed to bid for enlisted items.
4. The Earnest Money of unsuccessful bidders shall be refunded immediately after the completion of the auction.
5. The highest bidder shall be the purchaser and no bidder shall be allowed to withdraw his bid(s). If the highest bidder withdraws his bid after the fall of the hammer, his EMD shall be forfeited.
6. A bidder is expected to inspect the properties prior to the auction date at his/her own cost and the properties shall be sold on an **"as is where is basis"**. All properties are sold in their current state of repair and condition at the time of the auction or sale with all defects and faults latent or otherwise (if any). The auctioneer makes no warranties and gives no guarantee as to the condition, suitability, fitness for purpose or merchantable quality of any goods and the purchaser expressly acknowledges the same.
7. Upon acceptance of the successful bid by the Auction Committee, the highest bidder shall deposit 25% of the auction value by way of Cash or Cheque
8. The balance amount (75%) shall be deposited within 10 working days from the date of auction by way of Cash or Cheque failing which accepted bids shall be declared null and void, and a 25% deposit may be forfeited by the Auction Committee.

9. The purchaser shall be deemed to have physically inspected the property to their full satisfaction before making his bid(s).
10. The Company has the right to withdraw properties before the start of the auction without assigning any reason thereof.
11. The decision of the Auction Committee to accept or reject the bid without assigning any reason shall be final and binding.
12. If the winning bidder fails to lift the vehicles and machinery within the stipulated time, the bidder shall be levied Nu.500.00 (Ngultrum Five hundred) only per day for occupying the space.
13. All registration number plates of the government vehicles sold through public auction shall be removed upon taking delivery by the winning bidders.
14. The successful bidder shall bear transportation cost, fuel cost, maintenance of the property, and other expenses related to the property as it is sold on "As Is Where Is Basis".
15. The Company may initiate a transfer of ownership of the auctioned property only upon receiving full payment of the bid amount.
16. All expenses including sales tax, ownership change fees and other related expenses incurred for the change of ownership shall be borne by the successful bidder.
17. A complaint from the bidder shall not be entertained once the auction is completed.
18. Any bidder/person found guilty of syndication or fraud shall be liable for prosecution in accordance with the Anti-Corruption Act and other relevant laws of the Kingdom of Bhutan.
