Terms and Condition

1. Interested candidate shall pay Nu. 500.00 (Ngultrum Five Hundred) only, as an application and registration fee (*on or during the submission of the sealed bid*) which shall not be non-refundable.
2. The sealed bid will be opened on ^{19th} ~~20th~~ July 2023 at ~~10: A.M~~ ^{4:30 P.M} at BLDCL HQ (CDCL conference) by the review team and will be reviewed.
3. The selected applicant shall be informed on the same day.
4. In the event where the application is rejected, the relevant office will inform the applicant in writing of the decision outlining reasons for its rejection.
5. Selected dealer has to obtain the dealership license from the Department of Trade or any other relevant issuing agencies (if) and submit it to the BLDCL management at the time of signing the agreement.
6. The selected dealer shall deposit security deposit of Nu. 5,000.00 (Ngultrum Five Thousand) only in cash to Sales and Dealership Unit on the time of signing the agreement.
7. The dealer shall have minimum quantity lifting set by BLDCL unless specified otherwise.
8. The dealer shall abide by the minimum lifting quantity (*unless specified otherwise*) set and in case of failure to do so, BLDCL has the right to **TERMINATE** the Dealership.
9. The dealer shall be paid commission based on quantity being lifted as approved by BLDCL management, which is subject to **CHANGE** from time to time depending upon the strategic planning of BLDCL.
10. Upon the approval of the management, an agreement shall be signed between BLDCL and the applicant for the dealership.
11. It is advisable that the dealer have in place the necessary storage facilities such as freezer as per the nature of the product.
12. The agreement shall be reviewed or terminated with one-month advance notice by either party.
13. In case the dealer fails to notify BLDCL on cancellation of the Dealership before one-month, the security deposit shall be **FORFEITED**.
14. BLDCL shall fix the selling price of the products.


