1. The Bid must be submitted at or before **February 2, 2026**, at **11:00 am (BST)** to the Bhutan Livestock Development Corporation Limited and the bids shall be opened on the same day at **2:30 pm (BST)**
2. Any document received after the deadline for submission of bids prescribed by the BLDCL, shall be declared as “late” and shall be returned unopened to the bidder.
3. The bidders shall submit a copy of
 - valid licenses
 - Tax clearance
 - other necessary documents along with the bids.
4. All the bidder shall pay Nu. 300.00/ (Three hundred) only, as entrance fee, which shall be non-refundable.
5. For inspection, bidders are requested to visit the Livestock Value Addition Division, Serbithang, during office hours (9:00 AM to 5:00 PM).
6. The successful bidder must arrange their own logistics and measuring equipment to transport and measure the weight of the scrap items.
7. Interested bidders must duly fill in the price quotation for the different items mentioned in the price form.
8. The topmost successful bidder shall make a spot payment of 25% of the auction value and applicable GST on the full auction value. The remaining 75% of the auction value shall be settled within ten (10) working days from the date of the auction, on or before 5:00 PM.
